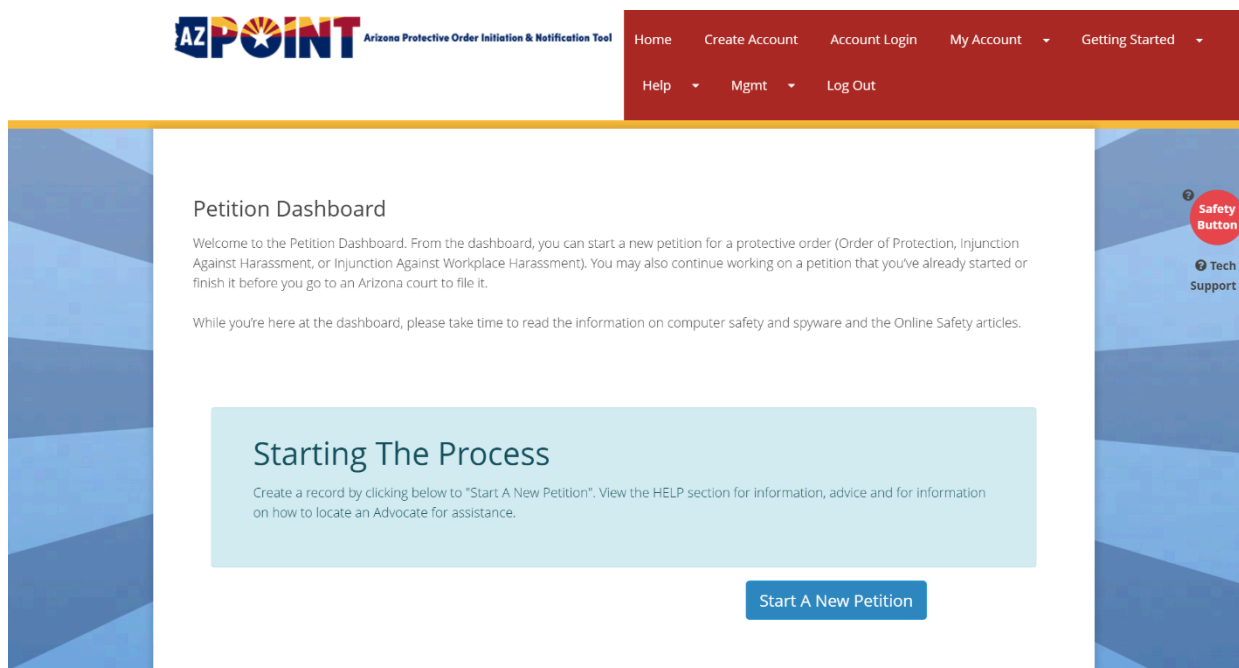


Website System Interface & Design: AZPoint

Built for the Arizona Courts System, the primary goal for the system was to create a clean, uncluttered interface for users to complete complex paper forms online.

The AZPoint project began in early 2019 as an effort to accomplish online and paperless forms actions for the Arizona Courts System. Before AZPoint, the public was unable to electronically prepare paperwork for filing a petition and were required to physically go to a court during business hours to manually fill out the paper petition.

AZPoint established an integrated electronic system to allow a person/plaintiff who is in crisis the ability to quickly and accurately submit paperwork electronically to an Arizona Court from virtually any location.

Within the system, document generation and the matching of printed two-sided 8.5x11 sheets of forms and documents was a priority. The aesthetics or design of a printed document was not an option for consideration as the generated online documents needed to match perfectly the original paper documents.

This example of an online generated document matched the original paper document in field placement, sizing and included proper formatting of all text inserted into fields.

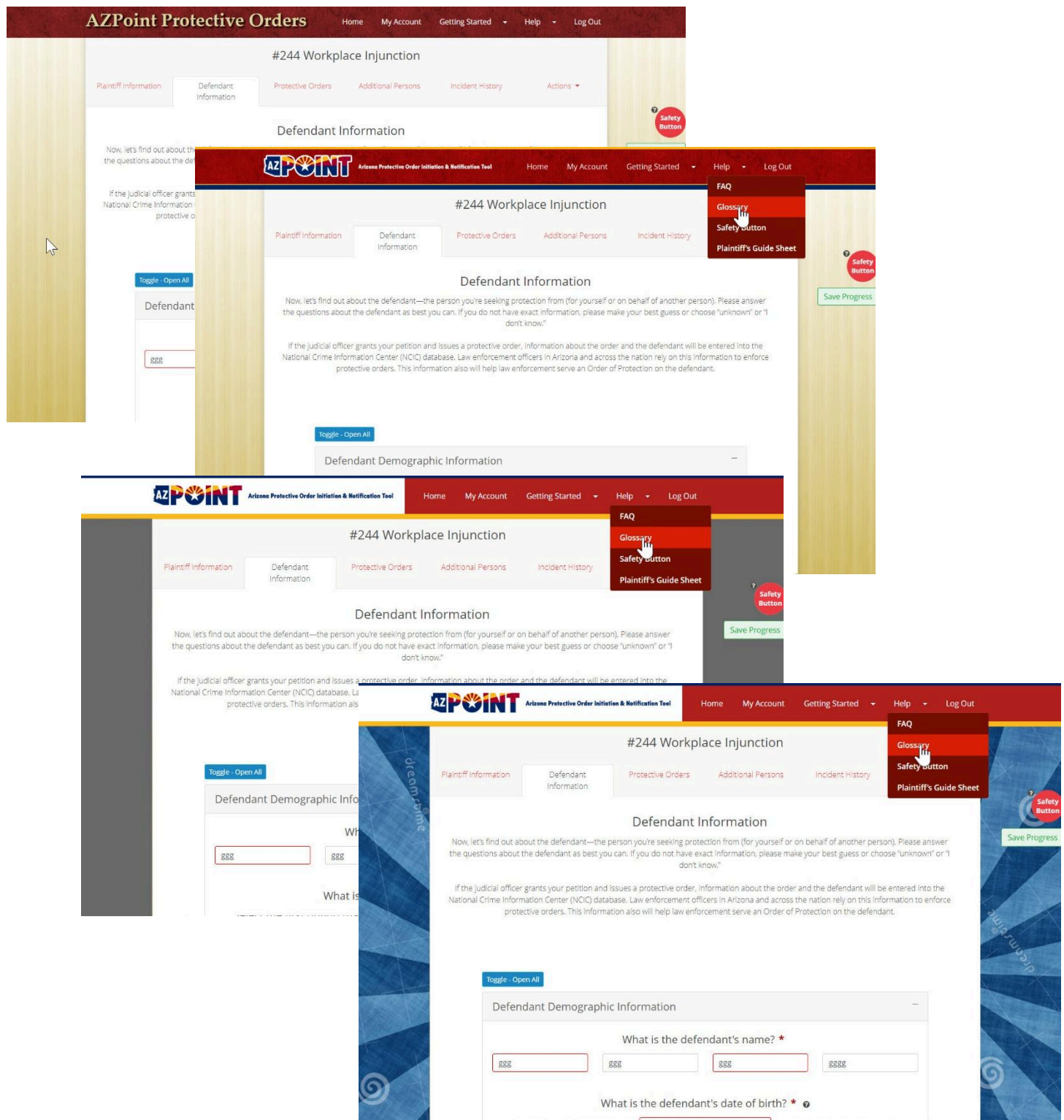

Plaintiff Information

Let's begin with information about you—the plaintiff. Your answers will be used to fill out the forms that you'll need to file a petition for a protective order at an Arizona court. You can stop and save your petition information at any time, and you can come back to it as often as you wish to continue working on it. If you don't return to your account for more than 90 days and continue working on your petition, your information will be removed. Information that is required is marked with a red asterisk*. Selected questions have tooltips (a question mark in a circle) that open when you float over them.

As the plaintiff, you can ask the court to issue an order for your own protection (or yourself and additional persons) OR on behalf of another person who needs protection, such as a minor or an adult who is temporarily or permanently unable to come to a court to file a petition.
